There are many different ways we could describe 2024. From a financial perspective, it was a tough year across all sectors and we know many other charities have been feeling the increasing pressure as well.

But this hasn't put a stop to the amazing work by Alzheimers NZ. One of the many highlights of 2024 is the development of our new strategy. Led by our Board Member Celia Patrick, we worked with our partners and friends to cultivate our new vision for the years ahead. We've put the voice of lived experience at the heart of our new strategy, and we're excited to bring this to life over the next five years.

On the advocacy front, securing a commitment from Government to implement and fund the [Dementia Mate Wareware Action Plan](#) continues to drive our engagement. We were pleased to meet with Associate Minister of Health Hon Casey Costello on a regular basis, alongside Dementia NZ, and that she could join some of our events.

The final two Repositioning Dementia events – which wraps up our series – provided an opportunity for the sector as a whole to progress the Action Plan. This is alongside the kaupapa of human rights and the lived experience and research! The success of these events has far exceeded our expectations, and we wouldn't have been able to pull them off without our friends and partners.

We couldn't do our work without the input of our Lived Experience Advisory Group. This group provides valuable input to ensure lived experience is central to everything we do – we appreciate you sharing so generously with us.

We also want to acknowledge the incredible work Alzheimers Members provide day-to-day for their communities. We know your work is appreciated by people living with dementia mate wareware and their whānau.

Of course, we couldn't do any of this without the sheer determination of the Alzheimers NZ Board, staff and volunteers. Thank you for the work you do – here's to another great year ahead.

- Influencing Government through our strong programme of advocacy, including engagement with Ministers, with officials including through the [Aged Care Review](#), our submission to the [Health Select Committee Inquiry into the aged care sector](#), recommendations for [Budget 2025](#) and with the Parliamentary Cross-Party Friends of Dementia Group (including an [Educational Dementia Immersive Experience \(EDIE\)](#) session)
- We've actively supported the first ever [national prevalence study of dementia mate wareware](#) and are contributing to this important kaupapa
- The launch of the [World Alzheimers Report 2024](#) on global attitudes to dementia mate wareware with responses from more than 500 people in Aotearoa New Zealand
- Launching groundbreaking research into the [influence of people living with dementia mate wareware in the planning and delivery of their services](#) and the [impact of peer support groups](#)
- Breakthroughs in mainstream media like [NZ Herald](#), [RNZ](#) and [Stuff](#) among others
- The Kings Honours List – congratulations to Board Member Alister Roberston who received his [Queen's Service Medal \(QSM\) for services to dementia mate wareware](#)
- Organisations recognised through our Dementia Friendly Recognition Programme – well done!
- We welcomed [Dementia Learning Centre Director Caroline Bartle](#) to build/drive innovative approaches to dementia mate wareware education
